Intellectual Property Law in Globalized and Digitalized Economies

You were in a party discussing with friends, you were at the coffee machine talking with colleagues, you were in a family dinner... when suddenly someone came up with a quotation from a movie. From which movie does this sentence come from? Is the citation correct? Who said it, and under which circumstances? The conversation can last for long before you find the answer...

"When there is a need, there is a market", Emma and Sean reminded their audience as they opened a meeting with potential investors. A few business angels were gathered to discover their project, called "*Bit Parts*". The website Emma and Sean envision would provide users with a mean to find the exact quotation, the name of the character or actor who said it, and the title of the movie. Once logged in, users would then be lured to download, rent or buy the whole movie, or would be invited to subscribe to other services provided by a company incorporated under the name 'Sean & Emma'. The website would target users in North America and Europe, to begin with.

In the first year, the service would be launched in beta, and would feature 10,000 classic film excerpts. Users will be able to search by actor, director, keyword, or line of dialog to call up the snippet they seek.

At a further stage, Emma & Sean plan to have a crowdsourced video-editing option, to lets users cut clips themselves or add additional search tags to improve the service.

At this point of their presentation, Emma and Sean feel they have not convinced the investors. But they have not reached yet the stage where they show concrete examples of the way the website functions.
